

Participation Conditions - Community Video Shorts

1. **Object**

ANKAMA GAMES, a simplified joint-stock company with capital of €1,000,000, located at 75 Boulevard d'Armentières, 59100 Roubaix, France, registered with the Lille Metropolitan Area Companies and Commerce Register (RCS) under number 492 360 730 (hereinafter "**ANKAMA**"), invites players to share video shorts in which they tell their story, their memories, or their experiences with the DOFUS, DOFUS Retro, DOFUS Touch or WAKFU games.

Some videos may be featured on ANKAMA's media platforms.

Participation implies and attests to the participant's unconditional acceptance of the following Participation Conditions.

2. **Participation Conditions**

Participation is open to players with a valid game account.

ANKAMA draws attention to the fact that any person considered to be a minor in their country of residence is deemed to be participating under the supervision and with the consent of their parent(s) or custodian(s), or in the absence thereof, their legal guardian(s). ANKAMA reserves the right to require written proof thereof at any time.

In all circumstances, if an entry submitted by a minor is selected for publication, ANKAMA will request written, signed parental consent in advance using Ankama's consent form. If the consent form is not received by the stated deadline, it will not be possible to post the entry.

3. **Consent to Use Entries**

By submitting an entry, the participant:

a. Gives ANKAMA consent to post their entry (displaying their nickname or not) to promote and/or communicate about Ankama Group activities and services on, for example, www.youtube.com, www.facebook.com, www.x.com, www.twitch.com, www.instagram.com, www.tiktok.com, www.ankama.com, www.dofus.com, www.wakfu.com, www.dofus-retro.com, www.dofus-touch.com and on any other website or social media of the Ankama group's subsidiaries.

b. Expressly warrants that they have full power and capacity to grant the rights transferred herein, and that these rights have been in no way transferred, pledged, encumbered, or in any way attributed to any third parties.

c. Warrants they are not bound by any exclusive contracts regarding the use of their likeness or voice.

d. Gives ANKAMA and the subsidiaries of the Ankama group consent to display, reproduce and publish their entry and nickname as part of these requirements, in accordance with the provisions regarding the right of personal portrayal, and the terms hereof.

e. Acknowledges and accepts their entry may be subject to cutting, editing and changes arising from technical limitations or based on project needs.

f. Confirms, to the extent necessary, that the consideration for the foregoing uses and services is their interest in the services offered by ANKAMA, which they expressly acknowledge. Accordingly, they agree their interest is fully satisfied and **may not claim any compensation** for the use of the rights described herein. This express agreement is permanently binding and excludes any future claim for compensation.

g. Accordingly, they waive any cause of action against ANKAMA and the Ankama group's subsidiaries arising from the posting and/or use described herein, in whole or in part, regardless of the mode (for example, date, duration or format) and the means.

The entry may be exploited and used by ANKAMA globally, without limitation, for the maximum copyright term allowed by French and foreign law, and any current or future international conventions, including any extensions to such term, in whole or in part, in accordance with the modes of use set forth hereinafter.

ANKAMA is expressly prohibited from using the videos in any way that could threaten the participant's privacy or reputation, and from using the videos in any medium of a pornographic, racist, or xenophobic nature, or any other use resulting in harm or injury.

ANKAMA may, for project research relating to its game universe, create and share with third parties anonymous summaries of the anecdotes and experiences described by participants, without disclosing the entry itself, the participant's identity, or any elements allowing their identification, save prior consent otherwise by the participant in question.

4. Authorized Content

Participants agree to submit content:

- in accordance with applicable law and regulations;
- that does not infringe any third-party rights;
- free of any illicit, hateful, defamatory, discriminatory, violent, pornographic, or other content violating ANKAMA's General Terms of Use.

Participants warrant they hold all the rights and consents required for the contents of their entry, for example, music, images, video clips, sound effects, or any other contents incorporated in the video.

Participants also warrant they have obtained the consent of any persons who may appear in their entry or whose voice may be heard therein.

5. Selection and Posting of Entries

ANKAMA reserves the right to select, post, feature, edit, take down or cease to post any entry, at any time, for example, for any quality, editorial, community, technical, or other reasons regarding these Participation Conditions.

Submission of an entry does not guarantee it will be posted, featured or remain online.
